A proposal seeking Wildlife Clearance for project titled "Proposal for use of 21.29924 ha from Sultanpur Wildlife Sanctuary for SGT University, Medical College cum Hospital and Research Institute at Village- Budhera, District-Gurugram, Haryana, FP/HR/ Others/5100/2020" was considered and recommended by the Standing Committee of the National Board for Wildlife in its 73rd meeting held on 17 July, 2023 under the Chairpersonship of Hon'ble Minister of Environment, Forest and Climate Change, Government of India. The recommendation of the Standing Committee for Wildlife Clearance for the above titled project is subject to the following conditions:-

I. The requested permissible height restriction of (up to) 21 meter is permitted for the cause of integrity of planned structure keeping in view the fact that the permissible height restriction imposed prior to 18.06.2021.

II. Additional permissible ground coverage of 28,606 sq. meter is allowed for this ongoing facility for health institution, which is in midway of being fully established.

III. Permissible built up area within the restriction of raising the height of buildings up to a maximum of 21 meter, may be allowed.

IV. The User Agency shall comply with the Ministry's notification S.O. 191 (E) dated 27.01.2010 regarding declaration of Eco-sensitive Zone of Sultanpur National Park

V. The proposed Conservation Plan with a cost of 2.80 crore will be implemented. Project Authority will deposit the amount in the O/o Divisional Wildlife Office, Gurugram as per Conservation Plan.



- VI. The clearance of the forest related laws, rules and instructions will be obtained from the Conservator of Forest (Forests Conservation)/or Concerned Territorial Wing of Forest Department.
- VII. The project proponent will seek necessary/mandatory permissions from the other concerned departments as applicable and will not violate the Hon'ble Court order, if any.
- VIII. All activities inside Eco-Sensitive Zone, will be implemented in consultation with Divisional Wildlife Officer, Gurugram/DFO (T), Gurugram. Project Authority will not violate by any means the Wild Life (Protection) Act, 1972.
 - IX. Noise limit of all the construction equipment's etc. should be fixed as guided by any expert deputed by the Forest/Wildlife Department.
 - X. Project Authority will not violate any provision of Ministry of Environment and Forest notification dated 27 Jan, 2010 regarding Eco Sensitive Zone of National Park.
 - XI. Project Authority will not extract any ground water with in the limit of Eco-Sensitive Zone.
- XII. Light reflector be established opposite to the Sultanpur National Park.
- XIII. Flow of medical-bio-waste generated not towards to the Sultanpur National Park.
- XIV. The quarterly compliance certificate on the stipulated conditions should be submitted by the project proponent to the State Chief Wild Life Warden.
