I am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 3rd Batch of MBBS students against the increased intake i.e. from 100-150 for the academic session 2019-20 at Sree Guru Gobind Singh Tricentenary Medical College Hospital & Research Institute, Gurgaon.
