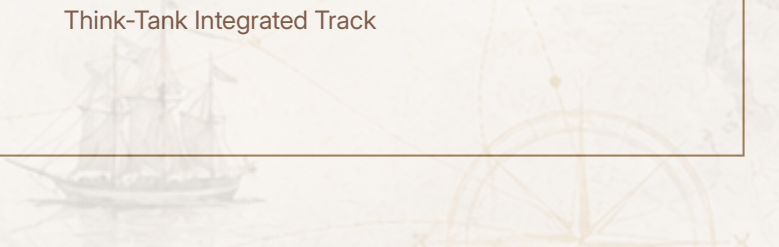

Intellectual Framework

"South Asia is more than a geographic region. It is an intellectual idea. This programme is your immersion into it."

The MA in South Asian Studies — The Idea of South Asia is a one-year, research-led postgraduate programme designed to produce rigorous, analytically sophisticated graduates capable of engaging with South Asia across its historical, cultural, political, and economic dimensions. Jointly offered by the School of Humanities, Social Sciences & Liberal Arts, SGT University, and the Advanced Study Institute of Asia (ASIA), the programme is structured across two intensive semesters.

Semester 1 establishes a shared conceptual and methodological foundation through core courses spanning four thematic pillars. Semester 2 moves toward specialisation through elective courses and culminates in an independent research thesis.

ASSESSMENT PHILOSOPHY & RIGOUR

Students are assessed entirely through written work — essays, field reports, and a research thesis — aligned with FHEQ Level 7 / 60 ECTS / UGC NCrF 80 credits. There are no timed examinations. This reflects a deliberate pedagogical commitment: the forms of knowledge produced in South Asian Studies — interpretive, historically situated, analytically complex — are best demonstrated through sustained written argument.

What Makes This Programme Different — The ASIA Effect

Students in this programme are embedded in the Advanced Study Institute of Asia (ASIA) — one of India's foremost multidisciplinary policy and research organisations. This is not an affiliation. It is active integration. Most programmes teach South Asia. This one lets students learn while working within a functioning policy and research institution — attending high-level discussions, engaging visiting scholars, contributing to publications, and observing real institutional decision-making.

LEARN SOUTH ASIA WHILE WORKING ON SOUTH ASIA

Students spend four days per week at SGT University and one day each week at ASIA, contributing from Day 1 to live projects:

- **Sensemakers** — public policy analysis platform
- **Decypher** — ASIA's weekly research newsletter
- **Woh Dilli** — urban and cultural documentation
- **Living Constitution** — constitutional scholarship initiative
- High-level policy dialogues and public events
- Research projects and academic publications

WHY 1 YEAR?

The accelerated one-year format is designed for graduates who already hold a 4-year degree, working professionals, researchers, journalists, and policy practitioners who want a globally benchmarked, intensive academic credential without a two-year commitment.

1-Year MA = KNOWLEDGE + EXPOSURE + DISSERTATION

Four Pillars of South Asian Studies

The programme is organised around four interconnected thematic pillars that together constitute the intellectual terrain of South Asian Studies.

01

History, Memory & The Making of South Asia

Historiography, archives, empire, partition, nationalism, public memory, and the contested production of historical knowledge.

02

Culture, Heritage & Knowledge Systems

Language, oral traditions, crafts, manuscripts, heritage institutions, cinema, religion, and the production of knowledge across generations.

03

Politics, Power & The State

Constitutions, citizenship, democracy, governance, social movements, law, rights, and how power operates across formal and everyday political life.

04

Economy, Development & Social Inequality

Economic history, development policy, labour, caste and class inequalities, climate, urbanisation, and regional disparities across South Asia.

Programme Structure

SEMESTER 1 — FOUNDATION (20 CREDITS)

All students complete a shared set of compulsory and core courses establishing a common conceptual and methodological foundation.

Foundations of South Asian Studies

2 CREDITS

Intensive 2-week gateway course. Establishes three habits of mind: precision about concepts, attention to context, and scepticism about received narratives.

Research as Practice (incl. Field Visit)

2 CREDITS

Semester-long methodological training with an organised field visit to a heritage site, archive, or development institution. Assessed by 2,000-word field report.

The Social World and Cultural Heritage

4 CREDITS

Four modules covering culture theory, craft traditions, orality and memory, and heritage representation in South Asia.

Making of the Past: History and Historical Practice

4 CREDITS

Four modules spanning historiography, early South Asia, medieval political cultures, and colonialism and resistance.

Understanding the South Asian Political Landscape

4 CREDITS

Four modules on political thought, constitution-making, nationalism, and democratic practice across South Asia.

Economic Change and the State in South Asia

4 CREDITS

Four modules on post-independence economies, planning, the reform era, and welfare state evolution.

Programme Structure

SEMESTER 2 — SPECIALISATION & RESEARCH (20 CREDITS)

Students choose four elective courses from four thematic clusters. Choosing three or more from one cluster is recorded as a Minor. The semester culminates in the Research Thesis.

Admissions

ELIGIBILITY CRITERIA

Graduates from any recognised university, any discipline, with a minimum of 60% aggregate. A 4-year Bachelor's degree is required for the 1-year accelerated programme. Relevant professional experience in research, civil society, policy, or media is treated as a substantive asset.

SELECTION PROCESS

Admissions are based on a holistic evaluation:

- **Statement of Purpose:** 600–800 words (written or audio-visual)
- **Sample of work:** 500–1,500 words of written or analytical work
- **Interview:** 30-minute panel interview for shortlisted candidates

Applications reviewed on a rolling basis.
