Notification

It is notified that the Academic Council has approved the First Amendment to the "**Minimum Standards and Procedure for Award of Ph.D. Degree**" Regulations, 2022, by Agenda Item No. 37.21 in its 37th meeting held on 15th May 2024. These amendments aim to enhance the academic and research experience for all our doctoral candidates and will be implemented with effect from 16th May 2024. The amendments are as under:

Grievances resulting from lack of reading / consulting these guidelines and information published/uploaded on the website of the University and/ or Departments time to time will not be entertained. i. Non-compliance with the requirements for admission, including non-submission of relevant documents and/or non-payment of Fee/s within the stipulated date and time, the candidate will lose his/her right to admission. j.
